

Limited Rental Damage Waiver

As outlined in "TERMS AND CONDITIONS OF RENTAL AGREEMENT" (See the rental agreement), "CUSTOMER ASSUMES ALL RISK AND LIABILITY FOR THE LOSS OF OR DAMAGE TO THE EQUIPMENT." Fresno Tractor, Inc., through their provider, offers to their customers "LIMITED RENTAL DAMAGE WAVIER" (LRDW) herein, should damage occur to the rented equipment supplied by Fresno Tractor, Inc. while in the customer's possession. REMEMBER THE (LRDW) ONLY COVERS SOME OF THE RISKS YOU HAVE ASSUMED. This waiver is not an auto liability policy and does not cover any on road vehicles (trucks or trailers). The "WAIVER" does not apply to the first \$1,000.00 of damage per occurrence. The cost of this waiver is an additional 12% of the rental rate.

"LIMITED RENTAL DAMAGE WAVIER" COVERS THEFT, ACCIDENTAL COLLISION, FIRE, LIGHTNING, EXPLOSION, WINDSTORM OR HAIL, SMOKE, AND OTHER ACCIDENTAL CAUSES. (SEE THE EQUIPMENT-IMPLEMENT DEALER STOCK FLOATER FOR DETAILS OF COVERAGE, TERMS, AND CONDITIONS). THE (LRDW) DOES NOT COVER DAMAGES FOR BODILY INJURY OR PROPERTY DAMAGE THE CUSTOMER IS LIABLE FOR. NOR DOES IT COVER DAMAGES TO RENTED EQUIPMENT CAUSED BY ADVERSE CONDITIONS (RENTAL AGREEMENT ITEM #15). DAMAGES CAUSED BY ABUSE, MISUSE, NEGLIGENCE OR NEGLIGENCE OF THE OPERATOR/RENTER IS NOT COVERED BY THE (LRDW) AND IS THE REQPONSIBILITY OF THE RENTER.

Only customers who provide Fresno Tractor, Inc. with a valid "CERTIFICATE OF INSURANCE" that names Fresno Tractor, Inc. as "LOSS PAYEE" for physical damage in regards to equipment rented from Fresno Tractor, Inc. may decline this coverage.
